1. Targeted house arrests (mostly ATD in proceedings + any additional people they find)
2. Pre-planned contact with ICE - check-ins, EOIR, getting called in to fix GPS monitor
3. Mass Raids - party (CO), worksite (KY, GA)
4. Menacing - check-points & parking lots
5. Other - state courts, etc

A: It depends!

- Maryland laws generally do not require you to produce ID to police on request outside of car stops and receiving citation. Montgomery County has a rule that allows police to detain you and requires you to truthfully identify yourself on request, even if you aren't driving or getting a citation.

VA

- It's not a crime to refuse to answer questions, except that you can be required to state your name. Some localities also require you to provide ID when asked. It is not clear whether these laws are constitutional, but refusing to comply could lead to criminal charges.

- If police ask for ID: MPD officers cannot force you to show ID (except for a driver's license if you're stopped while driving).
 - Note: The section following this says that federal immigration agents can force you to show them immigration papers. This is a little confusing. Because proving identity is often so central to an immigration case, it is helpful for immigrants to know when they have the right to refuse to identify themselves or provide ID. For example, Nevada has a statute requiring giving your name to an officer, but California does not. **However, even if a state law requires individuals to identify themselves, that may or may not apply in the case of a stop by federal agents such as ICE. No federal statute requires identifying oneself to federal law enforcement officers, and immigration officers do not have authority to enforce state criminal laws like Hiibel statutes.** Although ICE can arrest individuals who fail to carry their alien registration documents, they need probable cause to do so, and thus they would need to possess facts about a person's nationality and immigration status to make such an arrest.
